3. Target Participants (applicants must meet all of the following requirements):

- (1) Target participants should be nominated by the Intellectual Property Office in their countries.
- (2) Target participants should be engaged in the field of IPR.
- (3) Target participants should be university graduates and/or have equivalent professional experience.
- (4) Target participants should be physically and mentally prepared to undergo an intensive training course.
- (5) Target participants should not be students or armed forces personnel.
- (6) Target participants should intend to continue working in the same field after completing the training course.
- (7) Target participants should not have participated in the JPO/IPR training courses during FY 2014, in principle.
- (8) Target participants should have adequate English language competence to attend lectures and discussions, as well as make reports. (Please refer to the Part 6 of the Application Form.)
- (9) Target participants should have considerable knowledge of the IPR system, with more than three year experience in the field of IPR.
- (10) Target participants should be less than 50 years of age.
- (11) Target participants must be professionals working in one of the following positions:
 - 1) Patent attorneys and IP lawyers;
 - 2) Patent practitioners in private businesses; OR
 - 3) Officials at IP Offices who have a desire to acquire knowledge about patent practices.

4. Language:

Lectures, visits and discussions will be carried out in English, or in Japanese with translation into English. The course documents and training materials will be prepared in English.
